CURRICULUM

Theophilus College of Nursing, Kangazha follows the Curriculum prescribed by the Kerala University of Health Sciences, Thrissur.

GENERAL OBJECTIVE OF THE COURSE

At the end of four year BSc Nursing course the students will be able to :

- Assimilate the scientific knowledge from biological, social, behavioral and health sciences and apply it in providing nursing care
- Demonstrate leadership qualities and acquire skills in problem solving and decision making at different levels of work
- Utilize the latest trends and technology in providing care
- Practice standards of care within legal boundaries
- Collaborate with health team members and demonstrate skill in providing health care to all age groups at all settings.
- Evaluate the care and make the necessary changes in care
- Strive continuously to improve the quality of care
- Demonstrate skill organizing and providing health awareness and screening camps in hospital and community
- Maintain meaningful relationship with individual, family, community, colleagues and superiors
- Undertake and participate research projects to update the professional knowledge
- Organize and engage in continuing education programmes and update the knowledge
- Assume the responsibility of a citizen in a democratic society in continuing the development of society

I. ADMISSION PROCEDURE

- Theophilus College of Nursing is offering 4 year BSc Nursing Degree program with an annual intake of 50.
- College admits 25 seats from Government, 8 seats through Management and 10 seats reserved for Christian minority.
- NRI admissions 7 of seats allotted under NRI category.
- If any seats under Christian minority and NRI not filled it automatically convert to management.

Any student seeking admission at Theophilus College of Nursing must go through the prospectus carefully. Admission details will be updated in the college website time to time. The rules contained in this prospectus are subject to addition/deletion/ modification as may be deemed necessary subject to orders of competent authority/court of law.

II. ELIGIBILITY CRITERIA FOR ADMISSION

1.1. ACADEMIC :

- I. The minimum educational requirements shall be the passing of Higher Secondary School certificate (12 year course) or Senior School Certificate Examination (10+2), Pre-Degree Examination (10+2), or an equivalent with 12 years schooling from a recognized board or University, Kerala or examination equivalent there to as approved by Kerala University of Health Sciences, Thrissur.

Candidates should have a separate minimum pass mark for Physics, Chemistry and Biology and 50% marks in Physics, Chemistry and Biology put together.

II. Relaxation of marks

- Candidates belonging to Socially and Educationally Backward Classes with total annual family income up to 6lakhs, will have a relaxation of 5% marks. The Scheduled Caste and Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying examination.
- Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned. There will be no reservation of seats for SEBC or SC/ST candidates under management quota.

III. Eligibility Certificate:

Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

1.2. AGE

- Applicants should have completed 17 years of age on the 31st December of the year of admission (As per University norms). No relaxation of the minimum age will be allowed.
- Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth / copy of birth certificate should be produced at the time of admission

III. HOW TO APPLY

- A candidate who seeks admission to the Theophilus College of Nursing, Devagiri PO, Kan-gazha under the management/ NRI/ Community quota should submit an online application in the website of the college www.tcn.ac.in from 25th July 2025 to 25th August 2025.
- Application fee of Rs.1000/- to be remitted through payment gateway. Application submission will be completed only after the successful payment of application fee through online. Application fee once remitted will not be refunded in any circumstances. More than one application will lead to the rejection of application. Incomplete applications will not be considered
- Along with application form the following should be uploaded
 - Recent passport size photograph of the candidate
 - Mark list of qualifying examination
 - Signature of the candidate

1. Sponsorship Certificate
2. Attested copy of the passport of the sponsor
3. The attested copy of the relevant page of the passport where Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian Embassy or consulate.

*Relationship with the sponsor should comply the Government order No.GO(MS) No.193/2013/H&FWD dtd.22.05.2013& KUHS Order No.2836/ACB/kuhs/2014,dated 12.06.2014

IV. PREPARATION OF MERIT LIST

Merit list

- a) Out of 50% management seats 8 (15%) seats will be filled by managements from among the applications received on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria.
- b) Out of 50% management seats 10 (20%) seats are for the Christian minority.
- c) Out of 50% management seats 7 (15% of total seats) NRI seats shall be filled up from qualified students as per G.O (MS) No.243/2014/HRFWD dated 6.08.2014 of Govt. of Kerala.

Resolution of tie while ranking: In the case of a tie in the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.

Validity of the merit list: The published merit list will be valid till the allotment completion or the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.

Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

The Cut – Off Date of Admission

The cut – off admission to Nursing course will be as per the notification issued by the KUHS and Government of Kerala

Selection

Candidates will be called for interview and certificate verification by Selection Committee and select list will be prepared by the Committee. Candidates should produce original certificates and documents for verification at the time of interview.

Documents required at the time of admission will be intimated to the candidate later. It will also be present in the website.

V. IMPORTANT

- a) All admission related information will be available in the website.
- b) No personal messages will be given from institution.
- c) Submitting more than one application can lead to the rejection of candidature
- d) Candidate who do not complete the admission formalities on the specified date will lose their admission
- e) If there is any discrepancy observed in the entered details and the originals the admission will be canceled

VI. SPECIAL INSTRUCTIONS

Ragging According to the Kerala Prohibition of Ragging Act. 1998, 'ragging' means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such students will not in the ordinary course be willing to do.

- (a) All institutions will have to abide by the directives of the Honorable Supreme Court of India. Dated May 16, 2007 in SLP No. (S) 24295 of 2006 University of Kerala Vs. Council Principal's Colleges, Kerala & Ors. (with SLP(C) No. 24296-99/2004 and WP (Crl.) No. 173/2006 & SLP (C) No.14356/2005] and the recommendations approved by the Honorable Supreme Court of India on effective prevention of ragging in educational institutions.
- (b) Mobile Phone is not allowed to use during the duty hours (Theory and practical sessions)
- (c) Any other items not specifically covered in this prospectus will be decided by the Controller of admission.

In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later he/she shall be expelled from the educational institutions.

Each of the student of the institution and his/her parents or guardian are required to submit a combined, undertaking at the time of registration/admission in prescribed format (Annexure I enclosed) which is mandatory for registration/admission.

NRI Seat:

The management is entitled to fill up to 15% of total seats in NRI category by admitting qualified students who are dependence of NRI. According to GO (MS) NO.243/2014/H&FWD DATED 06.08.2014 "an applicant who depends upon his/her father/ mother/ brothers/sisters(inclusive of first cousin)/husband/wife/brothers/sisters(inclusive of first cousins) of father or mother/ half-brother/half-sister/adopted father/adopted mother who is working abroad will only be eligible to apply in NRI category seat.

VIII. SELECTION

The management and NRI rank lists of all applicants will be published separately on the website. The candidates will be selected only on the basis of merit on 26th August 2025. The website will be displaying the rank list, which will be compiled based on the scores received in the qualifying exam.

NRI Category

The following original documents other than mentioned above shall be submitted at the time of admission

Declaration of the Sponsor: (The candidate shall produce the sworn affidavit from sponsor in a stamp paper worth Rs. 200/- The same shall also be notarized by Notary public, disclosing that the student is dependent of the sponsor and all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the sponsor)
2. Relationship Certificate issued by Village Officer: (The certificate clearly establishing the relationship of the sponsor with the candidate shall be obtained from the revenue authorities , as per the G O (MS) No. 243/14/HGFWD dated 06.08.2014
3. Valid passport copy of the sponsor with Embassy Attestation
4. Valid Visa copy of the sponsor with embassy Attestation (Arabic Visa must be translated to English)
5. Employment Certificate of the sponsor with Embassy attestation. (The attested copy of the relevant page of the passport where Employment Visa is stamped or the employment certificate

IX. DISCONTINUATION

If any candidate discontinue the course, after admission cut-off dates notified by the authority, the candidates have to pay the tuition fee of the remaining year. The collection of liquidated damages will be as per law.

X. HOSTEL

Hostel facility is available for both boys and girls. All inmates must strictly adhere to the rules and regulations of the hostel. Any student who is expelled from the hostel once will not be permitted to have an entry again.
